AND REPAIR AND MAINTENANCE

Be it ordained by the Council of the Village of Venedocia, State of Ohio, two-thirds of all members elected concurring thereto:

Section 1. That sidewalks shall be constructed on both sides of all streets in said Village by the abutting property owners of the type and construction as hereinafter set forth.

Section 2. All sidewalks here nafter constructed shall be of concrete, cement, or asphalt type and constructed in accordance with the best practice and in a first class workman-like manner.

Section 3. All sidewalks shall be built on the line and on the grade as established by Council; and shall be constructed in such manner that they rise at least two (2) inches above surrounding sodded or ground area. If in any instance it is physically impossible, or if in the opinion of the Council it is not proper to locate a sidewalk on the line or grade established, then in that or either event the sidewalk shall be located on the line and on the grade as re-established by the Council.

Section 4. All sidewalks shall be constructed forty-eight (48) inches in width and shall have a one-quarter inch slope to the foot sloping towards the street so that all water shall run freely towards the street.

Section 5. All concrete or cement used in the construction of said sidewalks shall meet the requirements of the standard specifications of the Portland Cement Association; all asphalt used shall be that type of mixture known as Asphalt Cement.

Section 6. All sidewalks below the line and the grade established shall be raised to conform thereto and all sidewalks not constructed of cement, concrete or asphalt shall be repaired with one of said types of material.

Section 7. All sidewalks shall be kept in good repair, free from ice and snow or any nuisance.

Section 8. Any person violating the provisions of this ordinance relating to ice and snow or nuisance shall upon conviction be fined not more than fifty (\$50.00) dollars and sixty (60) days in prison or both.

Section 9. All ordinances or parts of ordinances in conflict with the provisions of this ordinance shall be, and the same are hereby repealed.

Section 10. That this measure is necessary for the health, safety, and welfare of the citizens of the Village of Venedocia and is necessary for the immediate preservation of public peace, health and safety and shall be in full force and effect immediately and on the day of its passage.
