Lee Lare has asked the council's permission to allow his son-in-law to move a house trailer, for the purpose of occupancy for a period of up to 2 years, onto a lot that already has a house on it. The purpose is for the family to have a place to live while they are remodeling the house.

The ordinance in question, #1969-1, states, as follows: "Section 2. On and after the passage of this ordinance, it shall be unlawful to place or suffer to remain a house trailer on the same lot containing an existing house, .....any habitation in excess of 24 consecutive hours shall be conclusively construed as establishing the intent to inhabit."


Everett Koenig made a motion that the council have the town's attorney, Stephen Gehres, draw up a paper to ammend Ordinance #1969-1 to allow Mike Leiter to move a housetrailer onto the lot previously owned by Len Millisor, for the purpose of occupancy while he is remodeling the house on the lot, and to be allowed for a period of not more than two years. Dick Coil seconded the motion. Motion carried.

The Mayor asked the council if they wished to recognize Small Business Week which will be May 8, 1983. In so doing, the council would be presenting each of the five small businesses in this town with a letter stating the town's support and appreciation of small businesses. Lee Lare made a motion that the council present each one of these small businesses with one of these proclamations. Everett seconded the motion. Motion carried.
